Type

This product is an unsecured debt instrument governed by English law.

Objectives

This product is designed to provide a fixed coupon on a periodic basis during the product life time. The Issuer is able to terminate the product at its discretion before the final maturity date. If the product is not redeemed early, the capital redemption amount is linked to the performance of the underlyings. Your capital will be fully at risk when investing in this product.

The Reference Underlying is the Underlying with the lowest observed level on the relevant observation.

Coupon

Provided that the product has not been previously redeemed early:

On each Coupon Payment Date, you will receive the Coupon.

Early Redemption

Final Redemption

On the Maturity Date, provided that the product has not been redeemed early, you will receive a final redemption amount.

- If the Final Level of the Reference Underlying is at or above the Capital Barrier, you will receive:

100% of the Nominal Value.

- Otherwise, you will receive physical delivery of the Reference Underlying. The number of shares to be delivered will be equal to the Nominal Value divided by the Conversion Factor and converted into the Settlement Currency using the applicable exchange rate on the Final Observation Date. If the number of shares to be delivered does not equal a whole number, the number of shares to be delivered will be rounded down and the remaining amount will be paid in cash in the Settlement Currency. As the value of the physical delivery is expected to be below the value of your initial investment when you receive the delivery, you are therefore likely to suffer a partial or total loss of your invested amount in this scenario.

The Conversion Factor is equal to the Initial Value multiplied by the Capital Barrier.

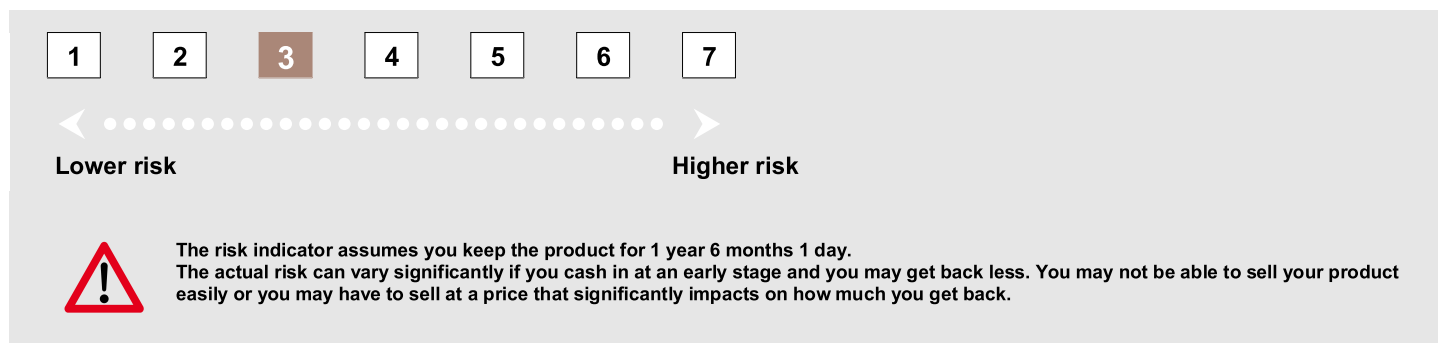

WHAT ARE THE COSTS?

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended Holding Period: 1 year 6 months 1 day, which corresponds to the product maturity.

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product by providing bid and offer prices expressed as percentages of the nominal value and the difference between the bid and offer prices (the spread) will not be more than 1.00% of such nominal value. If you want to sell the product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily or permanently suspended.
